

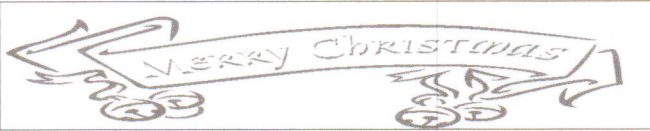

## Office policies

Scheduled office hours are 9 a.m. to 1 p.m. Tuesday—Saturday. These are the times scheduled for people to pay rent and/or discuss any **business related** matters.

People who are unable to be in the office during these hours due to work schedules and if office is closed at their availability, may call the manager at 580-565-9160 to make arrangements at a different time.

If paying by check or money order people may put item in an envelope and slip it under the door for when management arrives. If the latter is done, management will write a receipt and leave it at the tenants home so tenants will have the additional receipt for their records.

Business hours are delegated for **business only**. Please understand that while management and maintenance enjoys the company of tenants we are **at work** and as such, do not have time to visit during business hours.

The community center offers seating and an opportunity for people to visit, have some morning coffee or just relax with friends, while keeping the business office traffic free and open to those who come to the office to conduct business and/or allows maintenance and management to conduct the day to day business of Sunrise Family Resort.

## Home considerations

Please note that while we at SFR are fortunate to have both onsite management and maintenance, there are considerations that should be followed.

Just like anyone else who has a job, these parties are entitled to family time and not being interrupted for business matters when they are at home.
